Athens-Clarke County (remainder)	the part of the consolidated city that excludes Winterville city and Bogart town (pt.), effective January 14, 1991 (Census Place: 0146; FIPS: 03440)
Augusta-Richmond County (remainder)	the part of the consolidated city that excludes Blythe town (pt.) and Hephzibah city, effective January 1, 1996 (Census Place: 0166; FIPS place: 04204)
Augusta-Richmond County (consolidated city)	merger of Richmond County and Augusta city; effective 1/1/96 (Census Place B000; FIPS place; 04200); Blythe town (pt.) and Hephzibah city are part of the consolidated city but remain separate incorporated places.

Fargo city, Clinch County	new incorporation, effective April 1, 1992 (Census place: 1063; FIPS: 28744)
Georgetown city	area description change, from town to city, effective 1/1/90
Gillsville city	area description change, from town to city, effective 1/1/90
Graham city, Appling County	new incorporation, effective May 1, 1991 (Census place: 1230; FIPS: 34260)
Helena city	area description change, from town to city, effective 1990
La Fayette city	surviving entity in merger with Linwood town, effective July 7, 1993
LaGrange city	name correction, from La Grange to LaGrange, effective January 1, 1990
Linwood town	merged into La Fayette city, effective July 7, 1993
Lithia Springs city, Douglas County	new incorporation, effective February 9, 1993 (Census place: 1627; FIPS: 46832)
Mountville town	disincorporation, effective 1995
